- Submit a letter of recommendation from Scoutmaster, Crew leader or Team leader. Recommendation must include a discussion of activities relating to applicant's receipt of Girl Scout Gold Award or Boy Scout Eagle Award.
- Submit a minimum of one additional letter of recommendation from a person who is not related to you *other than* Scoutmaster, Crew leader or Team leader endorsing you as a candidate for receipt of scholarship. By way of example, a teacher can provide this recommendation.
  - On a separate piece of paper, write an essay (English only; no minimum or maximum length) on the following topic: ***What HOME means to me***. Essay must be entirely the original work product of applicant; third party assistance of any kind (e.g., from parent/guardian or teacher) is strictly prohibited.
