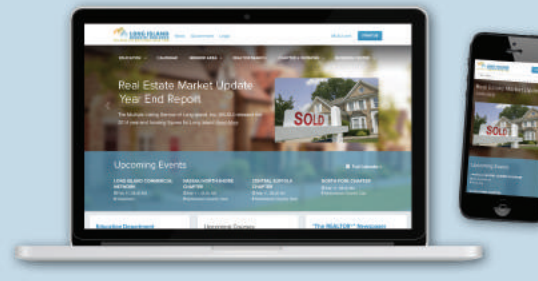

LIBOR offers programs and services designed to help you understand and avoid exposure to liability and risk.



Legal Helpline

The Legal Helpline gives you direct access to a Board retained, real estate attorney, who is available to answer legal questions that may arise. Simply e-mail your inquiries to the helpline attorney at LIRealtor.com/legal/legal-helpline – and your questions will be answered via phone or e-mail within 24 hours of the time the question was sent, if sent during the business week.

Legal Assistance

LIBOR, along with NYSAR and NAR, will provide financial support to legal cases that will establish a favorable precedent for the real estate industry.

Professional Standards

LIBOR offers its members and the public two distinct services regarding disagreements over the details of a real estate transaction. These services are filing an ethics complaint against a REALTOR® and requesting arbitration with a REALTOR®.

Arbitration: Resolving Commission Disputes

Arbitration is a legally binding process by which REALTORS® may request a hearing before members of the Professional Standards Committee when there is a commission dispute. There is currently a filing fee of \$350 per party to the Arbitration.

Mediation Process: A Less Formal Approach to Resolving Disputes

Mediation is available to Principals on a voluntary basis prior to the filing of an Arbitration Request. The mediation can be scheduled quickly without the necessity of filing any paperwork.

Mediation is also offered as part of the Arbitration Process after the Arbitration Request has been reviewed by the Grievance Committee.

Mediation is an informal dispute resolution process where the Principals, along with a Mediator, attempt to amicably settle their differences before they are required to attend a formal Arbitration Hearing.
